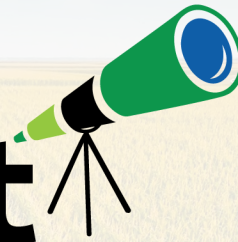

## Major Updates to EDGE Grain Released!

We are excited to share with you that earlier this month, we released a major update to our EDGE Grain package and were applied to all hosted systems on January 7th. Our dedicated team has worked tirelessly to bring this update to you, which includes nearly 60 important enhancements and fixes that are detailed with more information in PULSE.

We would like to point out that within the list there are three separate calls for Deferred Payments. These all go together to bring you the **new Deferred Payments tab** in the Grain Customer Portal. There are also three separate calls related to changes to Storage Charges. These all go together to change how we charge tax on storage charges. You can now charge storage per grain contract/control and charge a variable tax instead of just flat tax. Meaning you can charge a state and county tax on grain storage charges like in AR instead of just a flat tax rate of 6%, for example.

Starting with this release, we have implemented an additional layer of quality assurance. As part of this process, all calls have been thoroughly tested on our production system to ensure that the expected outcomes of each enhancement are correct. This meticulous testing process replicates how your system should respond, providing us with the assurance that our code is solid and reliable. Although this may add some time to the release process, we believe it is essential to deliver a high-quality product.
