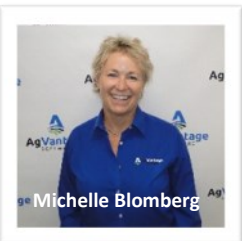




## Pacific Northwest Training Recap

Dawn Klingfus joined us remotely to walk through the new Credit Operations Portal. This is a brand-new menu where users can track a customer's assets and credit history.

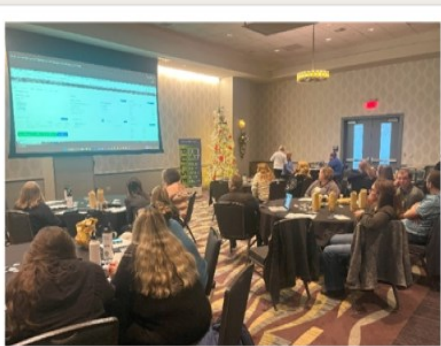
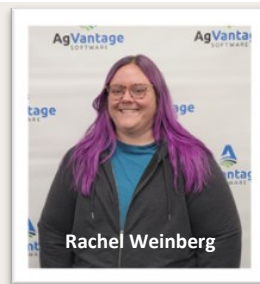


Kristin Ehlen joined us remotely showing new features in EDGE Accounts Payable and Bank Reconciliation.

### End of year Forms

For several years we have teamed up with Quality Resources as an option for our customers to purchase end of year forms. They are no longer offering this service. However, there are many websites, including Amazon, Walmart, Office Max/Office Depot, or you can check with your local office supply provider, to order forms.

*Due to the variety of printers used, if you do buy forms, please do a test print before running your forms to verify alignment.*

### 1099's

We highly recommend using the 1099 substitution letters for patrons and/or vendors and filing returns online. If you do use the letters and file online you DO NOT need to purchase 1099 forms.

### W2's

You will need the blank front, 4-up, horizontal perforated W2 forms that contain the required employee notice/instructions printed on the back. This is the form used for printing W2's from the AgVantage end of year menu. If you file the federal and state wage files electronically, you will need 1 sheet per employee.

### Payroll End of Year Additional Information

Remember, the rules regarding electronic filing of tax forms of various types changed in 2023. Electronic filing of W2 forms is now required for any business with more than 10 combined forms of various types. If this will be your first year filing electronically you can place a support request to get set up with the data transfer for federal wage files. Additionally, registration for the Social Security Administration's Business Services Online (BSO) changed last year. If you did not use BSO to upload wage files last year, it's likely your User ID and Password are no longer valid to access BSO services. Find details and registration information at [ssa.gov/employer/](https://ssa.gov/employer/). This would be a good task to get taken care of before the end of the year. The new registration process could take two weeks to complete. Both recipient's copy and electronic filing of W2's are due by **January 31, 2025**.

Check your state requirements on electronic filing. Some states require all employers to file electronically, some state requirements match the Federal W2 count threshold, and other states fall somewhere in between.

Year-end information and 2025 tax table updates will be released on the ASK (AgVantage Skills and Knowledge) communication tool in EDGE. PULSE notices will also alert you to updates. Customers without EDGE can request information by placing a support request at [support@agvantage.com](mailto:support@agvantage.com). The Federal withholding tax tables for 2025 have not yet been released by the IRS. We will also continue to watch for state withholding table updates and unemployment wage base changes and post those by state on ASK.

## 1099's End of Year Additional Information

The rules regarding electronic file of tax forms for 1099's changed in 2023.

Final regulations for the Taxpayer First Act, provision 2301, were issued February 21, 2023, by the Department of the Treasury and the Internal Revenue Service. Treasury Decision (TD) 9972 amends the rules for filing returns and other documents electronically (e-file). These regulations reduce the 250-return threshold to generally require electronic filing by filers of 10 or more returns in a calendar year beginning in 2024, tax year 2023.

Example: During the calendar year 2024, for the tax year 2023 filing season, Company W, is required to file 4 Forms of 1099-NEC, Non-Employee Compensation; 4 Forms of 1099-DIV, Dividends and Distributions; and 2 Forms of W2, Wage Statement; for a total of 10 returns. Because Company W is required to file 10 returns as calculated during the calendar year 2024, for the tax year 2023 filing season, Company W must electronically file all of its tax year 2023, Forms 1099-NEC and 1099-DIV with the IRS, and Forms W-2 with the Social Security Administration.

As of the date of this newsletter the IRS has not yet published filing deadlines. Please refer to the IRS website for filing deadlines and additional information on filing requirements.
